Award Amount: \$1,000 for travel expenses (including air fare, hotel and meals) and \$1,000 award plus complimentary registration to attend ACR Convergence 2022.

Guidelines

Eligibility

- All award recipients must abide by Foundation [Awards and Grants Policies](#) at all times
- The applicant must be a fellow enrolled in a recognized ACGME-accredited pediatric rheumatology program or a related research laboratory.
- The applicant must be an author or co-author of an abstract submitted to the 2022 ACR Convergence via the ACR/ARP abstract submission portal by the **Thursday, June 9, 2022**, deadline.
- The applicant must have made a significant contribution to the work submitted in order to be considered for the award.

Review Criteria

Each application will be ranked on the following criteria:

1. Evidence of abstract submission
2. Review of applicant's credentials
3. Relevance of the applicant's research to rheumatology

Applicants will be notified as to the status of their award in September.

Award Terms and Funding

Awardees will receive an award of \$1,000, plus complimentary registration to the 2022 ACR Convergence. This is a one-year award. A \$1,000 stipend will be provided for travel expenses (including air fare hotel and meals) to attend the 2022 ACR Convergence.

Note: Student will be paid a stipend in advance of meeting but, will be asked to submit original receipts to the Foundation following the meeting. Recipients will be issued a 1099 form for any funds NOT accounted for via receipts.

Funding Source

Funding for this award is made possible through an endowment from Amgen, Inc.

Application Instructions

Before starting the online application, you will be required to create a Professional Profile in ProposalCentral, if you have not already. To do so, visit [this link](#) to begin creating your account.

All files must be saved as a PDF. Documents that do not have a required template should be formatted with ½ inch margin, 11-point Arial Font, and single-spacing (does not apply to figures and tables). All applications and documents must be written in English and avoid use of jargon or abbreviations. If terms are not universally known, spell out the term the first time it is used and note the appropriate abbreviation in parentheses. The acronym may be used thereafter.

Note: The Foundation does not require official signature from an authorized institutional research office at the time of application. However, many institutions require an application to be reviewed prior to submission. Please check with your research office for your institution's requirements.

Applicant Information

You will be asked to confirm your eligibility and provide contact information in this section.

Applicant Resume, CV, or Biosketch

You will also be asked to upload the applicant's Resume, CV or Biosketch. Limit to 5 pages.

Abstract Information

- Abstract Title
- Author(s) Names
- Abstract control number (from ACR/ARP submission portal)

Required Documents

Statement of Applicant

Limit to 1 page.

Fellow must include the following:

- A. Details regarding their involvement in the project reported in the abstract.
- B. Details regarding their past achievements and future career plans.

Letter of Recommendation

Limit to 1 page.

The mentor must provide a letter of recommendation detailing the fellow's contributions to the research project and any achievements.

ACR Convergence Abstract Submission

A copy of the complete abstract. Applications received without a copy of the abstract submitted to the ACR Convergence will **not** be reviewed.

Please note that the Foundation does not have any information regarding the status of your abstract submission to the ACR or ARP. The ACR/ARP abstract selection process and the Foundation award selection process are conducted independently.
