- Applicant must be an author or co-author of an abstract submitted to ACR Convergence 2026 via the ACR/ARP abstract submission portal by the **June 9, 2026** deadline.
- Applicants will only be considered for funding based on the abstract(s) listed in their application. Multiple abstracts may be listed in the application, but the applicant's involvement must be justified for each abstract in the application.

Review Criteria

Abstracts must be accepted by the ACR to be eligible for consideration and applications are prioritized based on corresponding abstract scores. Applications are then evaluated using the following criteria:

- Applicant's demonstrated interest in the field of rheumatology
- Applicant's accomplishments, track record, and relevant experiences
- Applicant's contribution to each abstract submitted for consideration
- Demonstrated mentor support
- When necessary, priority may be extended to applicants listed as first author

Applicants will be notified as to the status of their award in September.

Award Terms and Funding
