# OUR MISSION

Advance research and training to improve the health of patients living with rheumatic diseases.

## Purpose

The purpose of this preceptorship program is to introduce medical and graduate students to rheumatology by supporting a 4-week or 8-week, full-time clinical or research experience in the broad area of rheumatic disease. Applicants have the option of selecting a Clinical or Research preceptorship when applying. The research preceptorship may include research seminar(s) attendance; rheumatology rounds; provisions for relevant coursework; or participation in research activities. Clinical preceptorships are not designed to replace a clinical clerkship in rheumatology. Programs should be designed as a "shadow" experience with the student observing the preceptor. The student should not be expected to perform independent patient management. Examples of such experiences may include observing patient contact in the clinical office, accompanying the preceptor on rehabilitation facility visits, hospital rounds and/or conferences at the preceptor's institution.

## Award Amount

\$4,000 for an at least 8-week research or clinical preceptorship or \$2,000 for an at least 4-week clinical preceptorship. An additional \$1,000 reimbursement for travel expenses (including airfare, ground transportation, hotel, and meals) to attend ACR Convergence.

**All applications must be submitted by 5:00 pm ET on the deadline day through [ProposalCentral](#).**

# Award Eligibility and Guidelines

All award recipients must abide by Foundation [Awards and Grants Policies](#) at all times.

## Eligibility

- The preceptor must be an [ACR](#) or [ARP](#) member at the time of submission and for the duration of the award (students are not required to be members at the time of submission).
- A preceptor may be eligible to receive the award multiple times; however, they must work with a different student each time. Previous student/preceptor pairs are not eligible to apply again.
- Awarded students/preceptees may only receive the award once.
- Students enrolled in U.S.-based ACGME or AOA COCA accredited medical schools, undergraduate students who have been accepted into medical school, students enrolled in an accredited graduate school, or undergraduate students who have been accepted into graduate school, are eligible to apply.
- Students may apply during any year of their medical or graduate studies and must have identified a preceptor by the time of the application.
- Preceptors who have a familial relation with a proposed student are not eligible to serve as the student's preceptor.

Interested students can search the [ACR/ARP member directory](#) for a rheumatologist or rheumatology health professional in their geographic area.

## Review Criteria

Each application will be reviewed on the following criteria:

- Relevance of the proposed experiences to the rheumatic disease field
- Preceptor's credentials as related to the project and previous experience(s) as a mentor/sponsor
- Appropriateness and feasibility of student's role in the experience or project

- The clinical or institutional environment, including experiences specifically designed for students

All awardees will be notified within 6 weeks of the application deadline, and all award payments will be made within 2 weeks of receipt of required paperwork.

## Award Terms and Funding

Students must complete the 4 or 8-week preceptorship within 12 months from the award start date. The project must be completed within the proposed project dates. Students will receive a stipend or may waive the stipend and receive the preceptorship as a college elective credit. Preceptors will receive funding that may serve as a stipend or be used to cover related project expenses.

Students are also eligible to receive complimentary\* registration to attend ACR Convergence. Students are eligible to attend ACR Convergence in the year that they were awarded the preceptorship, OR the following year to allow time for abstract submission. Students must notify the Foundation prior to attendance to receive these benefits. A \$1,000 reimbursement will be provided for travel expenses (including airfare hotel and meals) to attend ACR Convergence.

### ACR Convergence

The ACR Convergence meeting features the latest innovations, science, clinical and business best practices in rheumatology. Awardees will get first-hand access to the latest discoveries and research transforming rheumatic disease care and clinical applications that will improve the health of patients. It is an opportunity to experience personalized learning that allows awardees to expand their knowledge to new areas of interest and focus in rheumatology. - \*Student/Resident ACR membership is required to receive complimentary registration to attend ACR Convergence. Membership is free to all student and resident awardees. Join ACR online at [ACR Membership](#).
- Based on federal tax guidelines, individuals receiving an award or grant of at least \$600 will receive a [Form 1099-MISC](#) for the calendar year in which payment was disbursed.

## Application Instructions

**Before starting the online application, you will be required to create a Professional Profile account in Proposal Central to begin creating your account at this [link](#).**

All files must be saved as a PDF. Documents that do not have a required template should be formatted with ½ inch margins, 11-point Arial Font, and single-spacing (does not apply to figures and tables). All applications and documents must be written in English and avoid overuse of abbreviations or jargon. If terms are not universally known, spell out the term the first time it is used and note the appropriate abbreviation in parentheses for use thereafter.

**Note:** This application does not require an official signature from an authorized institutional research office at the time of application. Institutional signature will be required if an award is received by the applicant.

## Applicant/Preceptee Information

You will be asked to confirm your eligibility and provide contact information in this section. In addition to the applicant information requested, you will be asked to upload the following documents listed:

### Preceptee Biosketch

Preceptee must submit a Biographical Sketch using the provided template. A [SciENcv-generated biosketch](#) will also be accepted. The biosketch is limited to five (5) pages, regardless of format.

## Preceptor Information

You will be asked to identify your preceptor and provide contact information in this section.

You will be asked to upload the following documents:

### Preceptor/Other Faculty Biosketch

Applicant must submit a Biographical Sketch using the provided template. A [SciENCv-generated biosketch](#) will also be accepted. The biosketch is limited to five (5) pages, regardless of format.

### Letter of Support - Limit 1 page

A letter of support is required from the preceptor describing the institutional environment (i.e., potential interactions with other trainees, other laboratories, etc.) and any proposed plans/experiences intended for the student during this preceptorship.

## Required Documents

### Project Proposal (Up to 3 pages)

- Description of student's current and future interests.
- Goals and expectations to be achieved in the preceptorship.
- Description of preceptor's previous mentoring experience (past five years). Please include any awards or recognition received and any teaching activities.
- Description of experience intended for the student and address how they will be accomplished during the preceptorship.
  - For clinical experiences: include clinical seminar(s) attendance, rheumatology rounds, provisions for relevant coursework, or participation in limited clinical activities.
  - For research experiences: include research seminar(s) attendance; rheumatology rounds; provisions for relevant coursework; or participation in research activities.

- Provide a list of other faculty/investigators the student may encounter regularly during this preceptorship. Please include names, explanation of their relationship and declaration of rheumatology related interests. Additional preceptors included in the proposal must provide a written statement citing awareness of their responsibilities and support of the proposal. If applicable, this statement can be uploaded in the “Review Attachments/Additional Uploads” section of the application.

## **Program or Department Director’s Statement (Limit 1 page)**

The Program or Department Director must provide a statement of support detailing the following (as applicable):

- Confirming the status of the applicant (i.e., student in a specific program, on leave from medical school, etc.) and their time to commit to the project.

## **Letter(s) of Recommendation from Additional Preceptors (Optional)**

Additional preceptors included in the proposal must provide a written statement citing awareness of their responsibilities and support of the proposal.
