Award Amount: \$1,000 for travel expenses (including air fare, hotel and meals) and \$1,000 award, plus complimentary registration to ACR Convergence.

Guidelines

Eligibility

- All award recipients must abide by Foundation [Awards and Grants Policies](#) at all times.
- Applicant must be one of the following:
 - a medical student enrolled in a U.S.-based LCME- accredited medical school, or a graduate student enrolled in an accredited institution.
 - a resident enrolled in a U.S.-based ACGME-accredited pediatric, medicine or combined medicine/pediatric residency program who is interested in rheumatology.
- Applicant must be an author or co-author of an abstract submitted to the 2023 ACR Convergence via the ACR/ARP abstract submission portal by the **June 8, 2023** deadline.
- Applicant must have made a significant contribution to the work submitted in order to be considered for the award.

Review Criteria

Each application will be ranked on the following criteria:

1. Evidence of abstract submission
2. Applicant's interest in the field of rheumatology
3. Support of nominee from faculty member
4. Accomplishments, track record and experiences of applicant

Applicants will be notified as to the status of their award in September.

Award Terms and Funding

Awardees will receive an award of \$1,000, plus complimentary registration to ACR Convergence 2023. This is a one-year award. A \$1,000 stipend will be provided for travel expenses (including air fare hotel and meals) to attend ACR Convergence 2023.

Note: Awardees are paid a stipend in advance of the meeting and are required to provide original receipts for all travel expenses. Travel funds not used toward travel to ACR Convergence may be considered taxable income.

Application Instructions

Before starting the online application, you will be required to create a Professional Profile in ProposalCentral, if you have not already. To do so, visit [this link](#) to begin creating your account.

All files must be saved as a PDF. Documents that do not have a required template should be formatted with ½ inch margin, 11-point Arial Font, and single-spacing (does not apply to figures and tables). All applications and documents must be written in English and avoid use of jargon or abbreviations. If terms are not universally known, spell out the term the first time it is used and note the appropriate abbreviation in parentheses. The acronym may be used thereafter.

Note: The Foundation does not require an official signature from an authorized institutional research office at the time of application. However, many institutions require an application to be reviewed prior to submission. Please check with your research office for your institution's requirements.

Applicant Information

You will be asked to confirm your eligibility and provide contact information in this section.

Applicant Resume, CV, or Biosketch

You will also be asked to upload the resident's Resume, CV or Biosketch. Limit to 5 pages.

Abstract Information

- Abstract Title
- Author(s) Names
- Abstract control number (from ACR/ARP submission portal)

Required Information

Statement of Applicant

Limit to 1 page.

The applicant must include the following:

- A. Details regarding their involvement in the project reported in the abstract.
- B. Details regarding their past achievements and future career plans.

Letter of Recommendation

Limit to 1 page.

The mentor must provide a letter of recommendation detailing the resident's contributions to the research project and any achievements.

ACR Convergence Abstract Submission

A copy of the complete abstract. Applications received without a copy of the abstract submitted to the ACR Convergence will **not** be reviewed.

Please note that the Foundation does not have any information regarding the status of your abstract submission to the ACR or ARP. The ACR/ARP abstract selection process and the Foundation award selection process are conducted independently.
